

# Notification in regard to Defunct the Haryana State Branch

## **NOTIFICATION**

Dear Member,

Greetings from Youth Hostels Association of India (YHAI).

This is to inform that the election of Haryana State Branch were due in June, 2017, however the same had not been conducted. As per Clause IX STATE BRANCHES (3) (b) of the Rules and Regulation of the Association provides that for the recognition of a State Branch, it is mandatory "that it has atleast 5 Units each comprising atleast 50 members". However Haryana State Branch is not fulfilling the criteria of five eligible units.

Haryana State Branch passed a Resolution by circulation among its State Executive and State Council members that Haryana State Branch would request the National Executive Committee in its meeting to be held on 24.9.2017 to consider allowing the National Council members from YHAI Haryana State Branch to participate in the forthcoming Elections of YHAI National Council and also that the State Branch, which could not hold its elections earlier due to inadequate membership in its 5th Unit, may be allowed to hold its Election at the earliest.

As per the request of the representative of Haryana State Branch in the National Executive Committee (NEC), the above resolution was placed before the NEC in its meeting held on 24th September, 2017 and it was considered by the members thoroughly. The members noticed the following inconsistencies while considering the request of Haryana State Branch:

1. The Haryana State Branch was not fulfilling the criteria of five eligible Units till September, 2016 which is mandatory for the election of any State Branch in 2017;
2. The term of Office Bearers of Haryana State Branch has already expired in June, 2017

After detailed deliberations and consideration of the rules and regulations, National Executive Committee decided to defunct the Haryana State Branch as the election of Haryana State Branch was due in June, 2017 and term of three years of its Office Bearers expired in June, 2017. Hence Haryana State Branch is became defunct State Branch.

As per Sub-Clause 3(f) of Clause F, members authorised the National Chairman to form an ad-hoc Committee for the functioning of the Haryana State Branch so that activities of the State Branch may be conducted smoothly. Accordingly, National Chairman has formed an ad-hoc Committee of Haryana State with the following members:
